# Information pursuant to Art. 13 EU Regulation 2016/679 for the Processing of Personal Data

#### **Data Controller**

We inform you that, pursuant to the EU Regulation 2016/679 (infra: "Regulation"), your Personal Data will be processed by VOIhotels SpA based in Via E. Lugaro 15, Turin, Italy as the data controller ("Data Controller").

## Types of data, purposes and legal basis

The Data Controller will process your personal data (art. 4.1 of the Regulations) by means of computer and telematic tools, using video surveillance systems installed at its hotels for **security and asset protection purposes** in accordance with the provisions of the General Data Protection Regulation (EU) 2016/679 ("**Regulation**") and on the basis of an agreement with trade union, or National Labour Inspectorate, or Territorial Labour Directorate.

<u>The legal basis</u> can be found in the pursuit of the legitimate interest of the Data Controller (Article 6.1.f of the Regulations).

The facility will be in operation 7 days a week, [including holidays]. The images are **recorded** and will be retained for a period of 72 hours They may be retained for longer in case of holidays or closure of offices or businesses, as well as in case we have to adhere to a specific investigative request of the Judicial Authority or judicial police. The legal basis is found in the fulfillment of a legal obligation to which the Data Controller is subject (art. 6.1.c of the Regulations).

This notice supplements the "simplified" notice provided through the signs placed at our cameras.

## Recipients of personal data

The images can be viewed by:

- natural persons authorized by the Data Controller to process personal data (art. 29 of the Regulations) by reason of their job duties and after signing a confidentiality agreement (e.g., employees of the Security Department, system administrators) appropriately instructed and supervised
- contracted third-party entities acting as Data Processors (Art. 28 of the Regulations). The complete

Images may be disclosed to the Judicial Authority.

The Controller does not transfer your Personal Data outside the European Economic Area.

#### Your privacy rights (ex art. 15 et seq. of the Regulation)

The data subject (filmed subject) has the right to request from the Data Controller, at any time, access to or deletion of his/her Personal Data or to object to its processing, has the right to request the restriction of processing in the cases provided for in Article 18 of the Regulations. Since this is data processed by means of the video surveillance system, the right to rectification and integration cannot be exercised in practice in view of the intrinsic nature of the data collected, since these are images collected in real time concerning an objective fact.

In any case, you always have the right to lodge a complaint with the Guarantor for the Protection of Personal Data, in accordance with Article 77 of the Regulation, if you believe that the processing of your data is contrary to the legislation in force.
